- When creating a test book for SOAP emulator, please identify this in the “Kliendisüsteemi ehitamise/versiooni number” / “Client System Build/Version Number” field by adding “using SOAP emulator” to the system description.
- HTTP Headers for test messages:
 - *User-Agent* – User for each test/request sent and identify your solution and current tested version.
 - *X-Forwarded-For* – use for situations where the IP address for the software that initiates the request is different from the end-user IP-address.
